1. Agrees, prior to participating, he/she will inspect the facilities and equipment to be used, and if he/she believes anything to be unsafe, will immediately advise his/her supervisor of such condition(s) and refuse to participate.
2. Acknowledges and fully understands that he/she will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from his/her actions, inactions or negligence of others, or the condition of the premises or of any equipment used. Further, that there may be other risks not known or reasonably foreseeable at this time.
3. Assumes all the foregoing risks and accepts personal responsibility for the damages following such as injury, permanent disability or death.
4. Releases, waives, discharges and covenants not to sue the Fort Hood Area Habitat for Humanity, Inc., its respective administrators, directors, agents, site supervisors, and other employees/volunteers of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leaseholders of premises, all of which are hereinafter referred to as "releases", from demands, losses or damages on account of injury, including death or damage to property caused or alleged to be caused in whole or part by the negligence of the "release" or otherwise.
5. **Photogenic Release:** Volunteer does hereby grand and convey unto Habitat all right title and interest in any and all photographic images and video or audio recording made by Habitat's home building program, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recording.
